EARLY TESTS – event committee may test 30 minutes prior to published start time

ROLL CALL/CHECK-IN – 30 minutes before your block

INSPECTION – for fitness, lameness, or "in-season" females following roll call/check-in

FUN RUNS – offered throughout day as time permits for \$5 a run

ENTRY INFORMATION

Each entry fee* - includes a \$3.50 per run AKC recording fee

(*an entry is defined as a single test by a single dog in a single event)

Entries can be made by mail to the Trial Secretary on an official AKC entry form.

Overnight or certified mail must be sent "No Signature Required".

No entries will be accepted by phone, fax, or hand delivery.

A \$25 collection fee will be added to the amount of each returned check.

Illegible or incomplete entries will not be processed and will be returned to exhibitor.

Returned checks or unpaid entries do not constitute a valid entry.

DOGS ELIGIBLE TO ENTER

Dogs who are twelve (12) months of age or older and registered with the AKC, recorded with Foundation Stock Service (FSS) program, registered with a foreign or domestic registry whose pedigrees are acceptable for AKC registration, granted a Purebred Alternative Listing (PAL) number, registered AKC Limited or Conditional, or enrolled in the AKC Canine Partners program are eligible to enter.

Dogs that are physically challenged due to loss of limb are eligible to enter and should be given the same consideration by the inspection committee as four-legged dogs. For safety purposes, any dog requiring an assistance apparatus, such as a wheeled cart, will not be allowed to participate.

A dog that exhibits a state of well-being at the time of inspection, shows no signs of physical discomfort, and in the opinion of the inspection committee appears to physically have the potential to safely complete the course, is to be considered fit to participate.

REFUNDS & CANCELLATIONS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Entries withdrawn for any reason are not eligible for a refund, except bitch in season or dogs determined to be lame or unfit to participate at the time of roll call by the Inspection Committee, by the owner/agent at the time of roll call, or upon previous notification by the owner/agent. A full refund will be issued for these exceptions.

ABOUT FAST CAT

Fast CAT is a timed straight race of 100 yards where the dog chases a lure. Dogs run individually earning points based on their handicapped speed. The handicap system is based on the height of the dog at its withers. There are no placements and titles are earned by accumulating points.

BCAT - 150 points, DCAT - 500 points, FCAT - 1000 points, FCAT# - every 1000 points Handicap - 18" or greater = 1.0, 12" to 18" = 1.5, less than 12" = 2.0

Points = MPH (204.545/time) x handicap

TIPS FOR HANDLERS

Dogs should be presented at inspection without tape, bandages, or wrapping/coverings of any kind. Bitches in season and dogs who are determined unsound or unfit by the Inspection Committee will not be allowed to participate.

It is strongly recommended that prior to running your dog that you have a good "recall" control over your dog as the dogs will be running off leash.

Handlers should wear comfortable shoes with good traction and should be physically able to hold and release their dog(s) as well as catch them.

Dogs are brought to the start line on leash and are released upon the verbal signal, "Tallyho!", from the Hunt Master. Dogs may be released by hand, folded leash, or using a traditional lure coursing slip lead.

Dogs may run with or without a collar. Unacceptable collars are choker collar, prong collar, or electronic collar. Tags hanging from collar should be removed or secured. Clips or rubber bands may be used to hold back dog's hair.

The catcher is expected to promptly secure the dog in the catch area and leave the field with the dog on leash.

Coursing is a physically demanding sport and, for the safety of your dog, your dog should be in good fitness and soundness. If you are unsure, consult your veterinarian.

Handlers are advised to warm-up and cool down their dog(s) by walking them for 10 minutes before/after their run.

Bring your own shade and water.

By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform the tests safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor or spectator whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. The Mid-Continent Kennel Club of Tulsa and its officers, representatives, volunteers, the Trial Chairperson/Secretary, Trial Committee, and Trial site assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assumes no responsibility for injury to children. The Mid-Continent Kennel Club of Tulsa reserves the right to decline entries for cause and may remove any dog on account of aggression. A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this trial.

REGISTER YOUR DOG WITH AKC

RUN TIMES

Dogs will be running concurrently in blocks and both of your runs will be in the same block.

Run times can be adjusted to allow for cooling down dogs between runs and to avoid conflicts with conformation ring show times. Please indicate on the entry form if you are competing in conformation. The conformation judging program will be reviewed when dogs are scheduled into blocks.

Run time preference may be indicated on the entry form.



TRIAL SITE INFORMATION

Battery-powered, continuous loop equipment will be used with lures consisting of white plastic bags. The length of run-out will be a minimum of 50 yards and up to 60 yards. The test surface is a dirt horse track and is flat with a chain link parameter fence. The test track will be fenced with temporary fencing. An electronic system will be used with manual timing as a back-up.

AKC CODE OF SPORTSMANSHIP

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance, and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions, and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a
 judge where it might reasonably appear that the judge's
 placements could be based on something other than the merits
 of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations, and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
